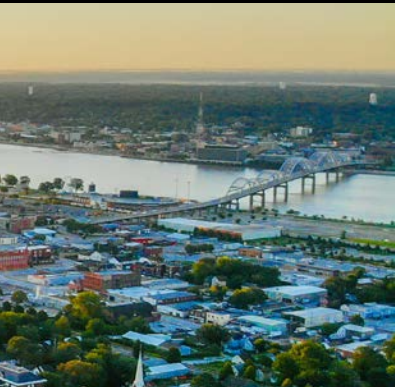

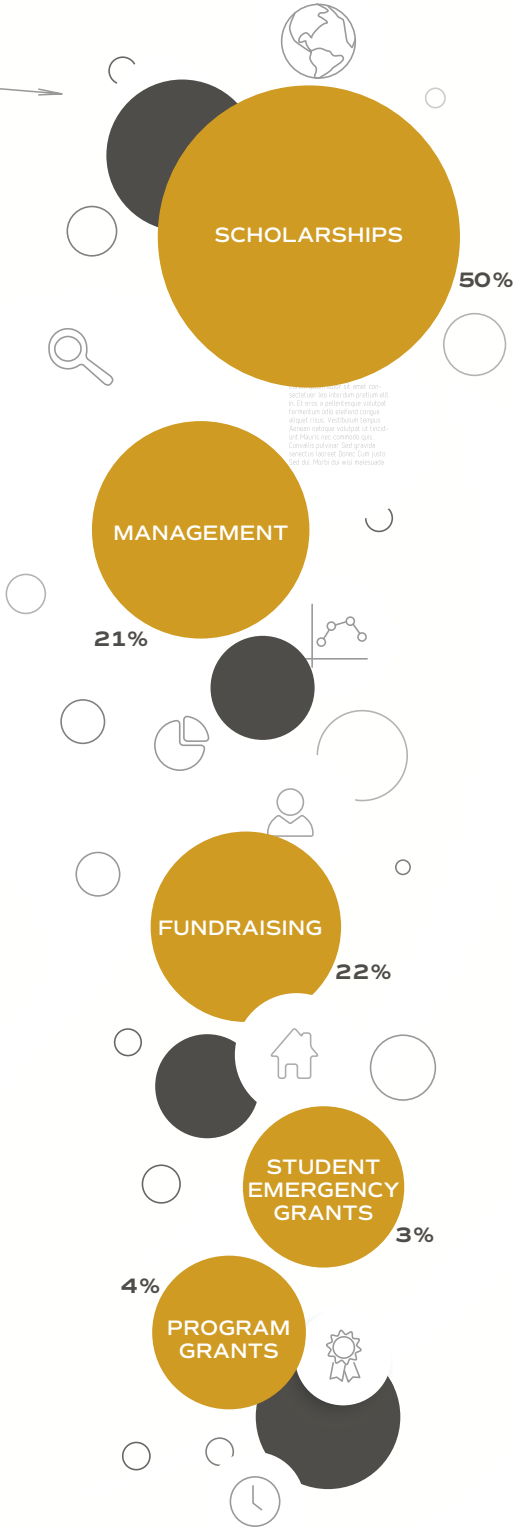

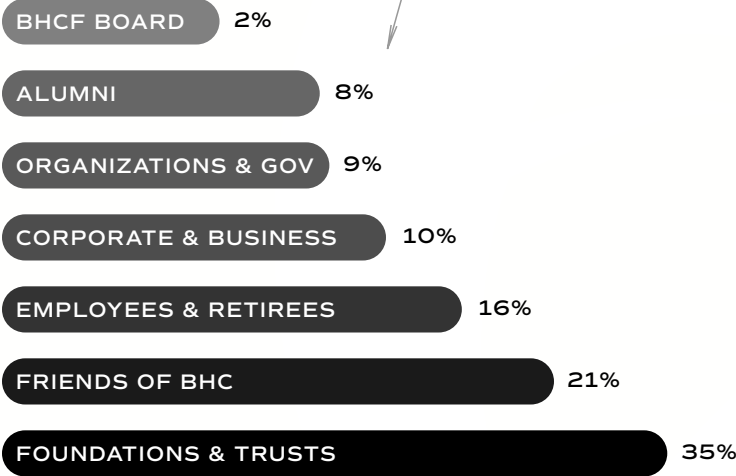

COLLABORATION & AWARENESS

In the Spring of 2017, the Black Hawk College Foundation Board began the process of refining our strategic plan for 2018–2021, which was adopted in the summer of 2018. The plan reveals three core goals: **development** through revitalized efforts towards raising funding; **awareness** with a focus on increasing the Foundation’s name recognition throughout the region; and **collaboration** by enhancing the relationship between the Foundation Board and the Black Hawk College Board of Trustees.

Also of paramount importance, is successful **leveraging of community partnerships** across all industries represented within the Quad-Cities community—with an emphasis on those with strong Black Hawk College and alumni ties. As we continue strengthening external relationships, through our scholarship and emergency fund grant programs we foster and cultivate a spirit of philanthropy among current students—tomorrow’s alumni.

A DYNAMIC AND RESPONSIVE BOARD

Last year, the Black Hawk College Foundation Board responded to the City of Moline Fire Department’s expressed need for a pipeline of applicants by offering scholarships for EMT and Paramedic students interested in becoming firefighters. In August of 2018, the Board paid the Black Hawk College application fees for 128 students to help build enrollment.

These examples illustrate our commitment to strengthening our community by helping build a more skilled and talented workforce.



EVENTS

ALUMNI HALL OF FAME & SCHOLARSHIP APPRECIATION BANQUET

We invite scholarship creators to share with students each year about their decision to establish a scholarship fund and the impact of their generosity for the Quad-Cities campus students.

The award recipients were invited to share their future plans and demonstrate how the scholarship has enhanced their lives. In addition our Alumni Hall of Fame inductees were honored at the event.

TELLING OUR STORIES GALA

This event celebrated community partnerships with organizations that support students and veterans. Vital funding through sponsorships, ticket sales and silent auction proceeds benefited Black Hawk College's new Surgical Tech program, Veterans Resource Center, and the Foundation.

The M*A*S*H-inspired theme transported attendees back to Korea in the 1950's with the swing-style musical entertainment from The Manny Lopez Big Band and the "surgeons" portrayed by in-district students from the cast of AlWood High School's fall play. Keynote speaker Martha Roskam's remarks about her families' mission of returning dog tags to Vietnam veterans moved us all.

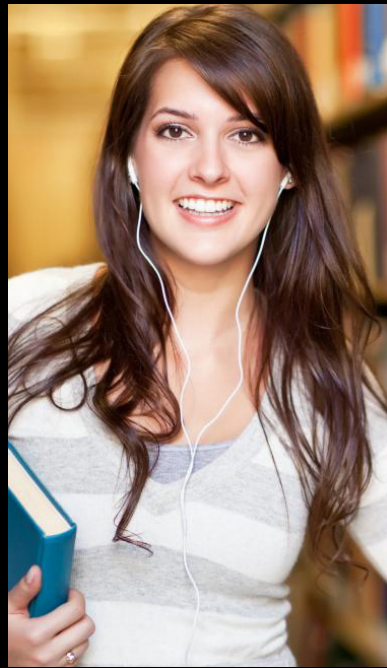
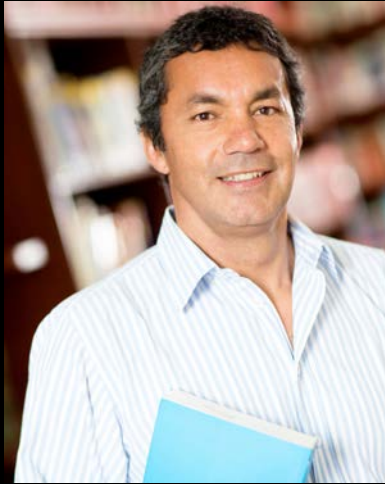

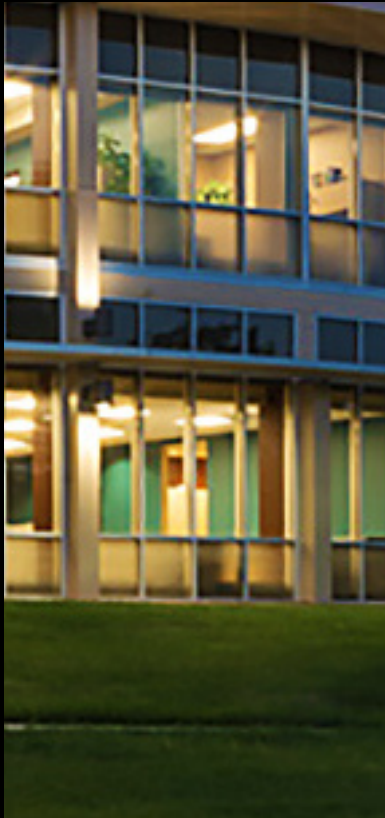
